

## NEW QUOTA WORK PERMITS FOR FOREIGNERS WITH SCARCE AND CRITICAL SKILLS

Please, be informed that the Minister of Home Affairs has announced the availability of 34 825 Quota Work Permits for skilled foreigners. Interested foreigners must have formal qualifications and at least five years practical experience. On application, the permit will be issued on successful applicants will be required to find a job in their field of expertise and to report to a Home Affairs office within 90 days of being issued with the necessary permission to enter the country by a South African diplomatic mission.

The permit will remain valid for as long as permit holders are employed within their areas of expertise, even if they change jobs. Permit holders under this system must confirm to Home Affairs annually that they continue to work in their designated professions.

The turn around time for the issuance of Quota Work Permits is 30 days and processing fee is £125. 00.
